No tender will be accepted without Bid Security & such tenders will be rejected. Tender will be submitted at the Purchase Cell of Punjab Institute of Mental Health, Lahore. In case of any official or local holiday, falling on the last date for submission of the bids, the next working day will automatically be the last date for submission and opening of the bids.
