ORDER

WHEREAS, M/S Jinnah Pharmaceuticals (Pvt.) Ltd. has been issued supply order of medicine Tab. Bromazepam 3 mg quantity 500,000 tablets vide this office letter No.20976/PIMH dated 29-07-2022. The delivery period of the said medicine was 60 days.

AND WHEREAS, A Show Cause notice, vide No.30491 dated 10-11-2022 was issued to M/S Jinnah Pharmaceuticals (Pvt.) Ltd. for non-supply of medicine Tab. Bromazepam 3 mg Quantity 500,000 tablets with the following charges: with the remarks that why your performance security should not be forfeited and your company should not be black listed.

"Special Condition clause 09: Penalties/ Liquidated Damages.

- A. In case where the deliveries as per agreement
- B. are not completed within the time frame specified in the schedule of requirement, the Agreement to the extent of non-delivered portion of supply may be cancelled or may be accepted with late delivery charges. If no supplies shall be accepted then the amount of Performance Guarantee/ Security to the extent of non-delivered portion of supplies of relevant item shall be forfeited and the name of firm shall be recommended for blacklisting to the Competent Authority. If the firm fails to supply the whole supply, the entire amount of Performance Guarantee/ Security shall be forfeited to the Government account and the name of firm shall be recommended for blacklisting".

AND WHEREAS, the firm was directed to submit written reply within 07-days. The representative of the company appeared in person and told that the said medicine is controlled medicine and the case is under process with DRAP but did not submit any written document in its defense.

AND WHEREAS, M/S Jinnah Pharmaceuticals (Pvt.) Ltd. was once again issued a show cause letter vide No.17129/PIMH dated 05.07.2023 with the same charges & remarks and was directed to submit written reply within 07 days.

AND WHEREAS, M/S Jinnah Pharmaceutical (Pvt.) Ltd. submitted written reply vide letter No. Nil dated 13-07-2023, which was received in this office vide diary No. 4278 dated 15-07-2023 without any documentary proof/evidence to justify his defense. The reply was unsatisfactory.

AND WHEREAS, M/S Jinnah Pharmaceutical (Pvt.) Ltd. was issued a letter for personal hearing vide No.17850/PIMH dated 14.07.2023 to appear before undersigned dated 20.07.2023 at 10:00 AM.

AND WHEREAS, the representative of M/S Jinnah Pharmaceutical (Pvt.) Ltd. Mr. Imran telephonically communicated with the committee and repeated the same stance which was received in this office vide diary No. 4278 dated 15-07-2023, but failed to justify his stance before the undersigned.

AND WHEREAS, M/S Jinnah Pharmaceutical (Pvt.) Ltd. was once again issued a letter for personal hearing vide No.20203/PIMH dated 08.08.2023 to appear before undersigned dated 16.08.2023 at 10:00 AM but the firm once again did not submit any written document in its defiance nor presented itself before the committee.

AND WHEREAS, M/S Jinnah Pharmaceutical (Pvt.) Ltd. was called third time in personal hearing vide No.6677/PIMH dated 02.03.2024 to appear before undersigned dated 08.03.2024 at 10:00 AM but the firm M/S Jinnah Pharmaceutical (Pvt.) Ltd. submitted written reply vide letter No. Nil dated 02-03-2024, which was received in this office vide diary No.1436 dated 05-03-2024 without any documentary proof/evidence to justify his defense. The reply was once again unsatisfactory.

NOW THEREFORE, I Dr. Farakh Abdullah, competent authority in this case decided that the charges leveled against M/S Jinnah Pharmaceutical (Pvt.) Ltd, 12 KM, Lahore Road, Multan Pakistan have been proved and imposed the following penalties:

1. Cancel supply order No.20976/PIMH dated 29-17-2022 against medicine Bromazepam 3 mg quantity 500,000 tablets.
2. Forfeiture of 05% performance security No.3550BC000001715 amounting to Rs.71,250/-.
3. Blacklisted / Debarred M/S Jinnah Pharmaceutical (Pvt.) Ltd, 12 KM, Lahore Road, Multan Pakistan to participate in any public procurement of this institute for a period of Three Years.

You are therefore directed to make a representation to Managing Director PPRA against this decision within 30-Days, if any.
